No hand deliveries will be accepted. Your complete Contest Submission must be postmarked no later than August 18, 2011 and received no later than 5:00 p.m. PT on August 19, 2011.

NO CONTEST SUBMISSIONS WILL BE RETURNED AND, IN FACT, MAY BE DESTROYED. G4 IS NOT RESPONSIBLE FOR ANY ARTWORK DAMAGED DURING TRANSPORT.

I UNDERSTAND THAT THIS AGREEMENT (“AGREEMENT”) IS AN IMPORTANT LEGAL DOCUMENT RELATING TO MY PARTICIPATION IN THE “2ND ANNUAL ATTACK OF THE ART SHOW” CONTEST (“CONTEST”), WHICH IS SPONSORED BY G4 MEDIA, LLC (“G4”). 4. I represent and warrant that neither my Contest Submission (in whole or in part) nor use of my Contest Submission by G4 will violate or infringe upon the trademark, trade name, copyright, right of privacy or publicity, property rights, or any other rights of any person or entity.
5. **I understand that by entering the Contest, I am transferring all of my rights, title and interests in and to the Artwork to G4, to the maximum extent permitted by applicable law, so that G4 will be the sole owner of all copyrights and other rights therein.**

 - (b) to edit, translate, dub or alter, separate, mix, combine with other material, reuse and adapt any and all portions or elements of my Artwork in any way and for any purpose whatsoever, at any time, now or in the future, in any media now known or hereafter devised, throughout the world, in any manner whatsoever and for any purpose in G4's sole and absolute discretion, including, without limitation, for humorous or satirical effect, even if the results may be considered embarrassing, derogatory, or otherwise offensive or injurious to me or other third parties.
7. I acknowledge and agree that G4 is not obligated to display my Artwork on any program or elsewhere. I understand that G4 may cancel the Contest at any time for any reason, without any obligation to me.
8. I acknowledge and agree that in no event will I have any right to rescind this Agreement or any of the rights assigned to G4 under this Agreement or to enjoin or restrain the development, production, launch, advertising, exhibition, or exploitation of any G4 programming.
9. In signing this Agreement, I have not relied on any statements that are not contained in this Agreement or the Rules. I agree that this Agreement, including the Rules, contains the entire understanding with respect to the above matters. I further agree that any oral representations or agreements made by G4 cannot be relied upon unless memorialized in this Agreement or in a writing signed by G4 and me.

I hereby agree to submit generally and unconditionally to the personal and exclusive jurisdiction and venue of a court of competent jurisdiction located in the City of Los Angeles, Los Angeles County, California. All issues and questions concerning the construction, validity, interpretation and enforceability of this Agreement, or the rights and obligations of the entrant and G4 in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules.
